#### From the minutes,

# MfS/16/07/05 Adoption of Agenda

The clerk has introduced the draft agenda, and we have agreed to this.

# MfS/16/07/06 Court and prison register

We have heard that five Friends who participated at the No Faith in Trident day of action at Burghfield on Monday 27th June 2016 are expected to appear in court. Jo Frew, attender at Tottenham LQM (North London AQM); Ellis Brooks, attender at Wandsworth LQM (Kingston and Wandsworth AQM); and Sam Donaldson, attender at Hull LQM (Pickering and Hull AQM) were arrested and released later the same day and will appear in court in August. John Lynes of Sussex East AQM and Hannah Brock of Hampshire and the Islands AQM were not arrested, but were issued with summonses to appear in court.

We will add these names to our Court and Prison Register, and hold the Friends in the light.

#### MfS/16/07/07 BYM Trustees

Ingrid Greenhow has spoken to the minutes of BYM Trustees' meeting held on 17-19 June. She has referred in particular to a new post to support Meetings with properties, funded from legacy funding; HS2; the use by Quakers of the large meeting house; changes to management meeting; and the EU Referendum.

We receive minute **BYMT/20/06/11** on strategic management, and forward it to Church Government Advisory Group.

#### MfS/16/07/08 Interfaith relations

We receive **minute 2016/3 Part 2** of **Leeds AM**, informing us that the Leeds Quaker-Jewish Dialogue Group, which has been meeting for five years, has produced a report that is being considered by the Area Meeting; and that the Dialogue Group continues its work.

We send this minute to Quaker Committee for Christian and Interfaith Relations.

#### MfS/16/07/09 End of Life Issues

In December 2014 Meeting for Sufferings spent time considering end of life, prompted in part by a minute from Leeds AM concerning assisted dying and in part by Quaker Life Central Committee (QLCC) consideration (minute MfS 2014/12/12c refers).

We now receive **minute 2016/32** of **Leeds AM**, informing us of the publication of 'Assisted dying: a Quaker exploration'. Copies have been sent to Local Meetings nationwide via Area Meetings.

QLCC has continued to address end of life issues. Quaker Life Representative Council in April focused on this topic, and a short leaflet 'Love and Loss' has been published.

# MfS/16/07/10 Refugees and Asylum Seekers

We receive minute 2/3/16 of Nottinghamshire and Derbyshire AM, concerning unaccompanied refugee children.

We also receive a minute of **Mid-Essex AM** held on 13 March 2016, supporting the suggestion of a conference to explore the issues surrounding the refugee crisis and the movement of peoples and how the Society might respond collectively and as individuals.

We have heard today from Helen Drewery, General Secretary of Quaker Peace and Social Witness (QPSW), that after careful consideration and listening to the experience of Friends actively involved in supporting refugees, as well as Meeting for Sufferings, QPSWCC decided not to pursue the possibility of signing up to a Private Sponsorship scheme initiated by Citizens UK (minute MfS/16/02/08 refers).

However, QPSWCC is supporting a project called Responding to Forced Migration. Legacy income has been allocated and BYM will shortly recruit a full time worker to build networks, share ideas and good practice and look for opportunities for Quakers to make a contribution to what is a rapidly developing picture.

Helen also informs us that the Quaker Asylum and Refugee Network (QARN) is planning a conference 'Forced Migration: how can Quakers respond?' to be held at Woodbrooke Friday 3rd to Sunday 5th February 2017. Other European Yearly Meetings will also be invited to this conference.

# MfS/16/07/11 Appeal Process

We receive **minute 16/16** of **Church Government Advisory Grou**p, recommending a review of the appeal process as described in sections 4.25 and 4.26 of *Quaker faith & practice*.

We agree to this. With some amendments made in our meeting, we agree to the Terms of Reference. We ask Central Nominations Committee to bring names forward to a future meeting.

#### MfS/16/07/12 Quaker World Relations Consultative Forum

We receive a minute of record from the Quaker World Relations Consultative Forum held on Saturday, 23 April 2016 at Friends House.

#### MfS/16/07/13 Arms Trade: UK sales to Saudi Arabia

Further to **minute MfS/16/04/15**, we receive part of **minute QPSWCC 16/56** responding to minutes from North West London AM and Ipswich and Diss AM, expressing concern about UK arms sales to Saudi Arabia, particularly in the light of violent conflict in Syria and Yemen. We note that QPSW is working closely on this issue with Campaign Against the Arms Trade (CAAT). Friends are encouraged to take action in support of its work. Quakers from across Europe joined recent protests outside the Eurosatory arms fair in Paris.

MfS/16/07/14 Conscientious Objection to Military Taxation
Further to minute MfS/16/04/16, we receive part of minute QPSWCC 16/56
responding to a minute of Dorset and South Wiltshire Area Meeting concerning a
Peace Tax Bill under the Ten Minute Rule, proposed by Ruth Cadbury, an MP who is a
Quaker. The AM asked what action the Society of Friends will take in support of this
Bill.

QPSWCC informs us that this initiative is being supported by the Peace & Disarmament programme, including through the placement of one of our UK Peaceworkers, Holly Wallis, with Conscience: Taxes for Peace Not War. Friends are encouraged to learn more and to contact their MPs.

We also receive **Minute 11 6/16** of **Northumbria AM**, informing us that, following a visit from Holly Wallis, it has adopted this as a concern.

# MfS/16/07/15 Lancaster University Court

For some years Meeting for Sufferings has appointed a representative to Lancaster University Court. We agree to pass responsibility for this appointment to Lancashire Central and North Area Meeting.

We forward this minute to Lancashire Central and North AM, and to Central Nominations Committee.

# Reflections on YM at MfS 2 July 2016

Main themes to emerge were:

### 1. Working with others and cooperation

James McCarthy suggested that we invite people from other groups that Quakers had in the past set up or encouraged, to feed in to us and to perhaps advise. Jane Pearn also felt that movement building meant linking with those we had worked with in the past and with whom there was trust and support. Aubrey Hill felt we needed greater understanding of how Friends work with other organisations where we are in unity with their aims – that there should be more of this and should encourage us all where we are, together. Bridget Walker wanted YM to focus on making joins so that we could be more connected with others in the different concerns that we had – she acknowledged it's difficult to know how to find a focus, when Quakers are active in so many things

#### 2. Reaching out to the people around us

Kim Noy-Man Jackson spoke about the great pain of difference that existed between us and others. His own meeting was able to sort themselves out but other local meetings were struggling with their environment and one was likely to shut. These are the places that need us — usually we are preaching to the converted and those who are employed and comfortable. The young are struggling with no employment and no accommodation. We need to offer our Meetings for Worship in those places that need the stillness. We are far away from where we are needed — this is the current challenge for us: to listen to that still small voice and offer opportunities for others to listen to it, away from the noise of the media and the politicians. Judith Mason also felt that we were too cerebral and put people off and that we needed to reach out to others in a more accessible way. Christine Fellowes emphasised the importance of listening to people around us and try to communicate. (My own feeling at this point was that there was something deep here about the mission that Quakers were called to — to go out and share what we have found in a simple way with all peoples around us.)


#### 3. Specific ideas

Andrew Backhouse suggested that we concentrated on taking one particular topic in workshops as well as plenary, and see what we can do with it in practice. Ingrid suggested having a specific session on Meeting Houses Heritage Project and perhaps having the new staff member speak to this. Graham Dragon wanted us to spend time with no agenda and to see what being truly open to the Spirit led to. There was a suggestion from James McCarthy that we should look at Meeting for Worship in an enquiring way to tap in to the source of power that we have there. Avril Dawson wanted Quakers to be more open about being Quakers; and in particular, for someone from Quakers in Business to talk. Rachel Berger wanted us to keep space as led for current events as they might happen and not to be too fixed in advance. Caro Kelly wanted us to focus on Our Faith in the Future and to consider how accountable we are for what we do and how we can make our vision more a living reality.

# **Management Meeting changes**

Management Meeting is composed of the Recording Clerk and other members of the senior staff. It is responsible for co-ordinating the management and overseeing the implementation of the work of Britain Yearly Meeting (Qfp 8.21). Its structure is changing. There will be five members of Management Meeting: the Recording Clerk, Deputy Recording Clerk, Head of Finance & Resources, Head of Operations, and Head of Worship & Witness. They will also have different roles, reflecting themes of work rather than departments.



#### Why are we doing this?

This is the latest step in a fairly long journey. Over the past century BYM has shifted from a pattern in which most "central" work was done by individual Friends acting under concern, with minimal paid staff overseen by separate, largely independent committees - to one in which centrally managed work for and on behalf of Quakers is carried out largely by paid staff overseen by committees within a central structure.

Back in 1994 Yearly Meeting noted a need for 'a clearer corporate vision'. In 2005, the RECAST report recommended 'slimmer central structures'.

The Trustee body was established in 2006. When the group set up to review the workings of MfS and BYM Trustees reported in 2011, it made several recommendations about Management Meeting. It asked for a clear protocol for the operation of Management Meeting; and for Trustees to prioritise building an effective relationship with the Recording Clerk - focusing on ways to ensure that staff implement the discerned priorities of Meeting for Sufferings.

In order to respond effectively to Our Faith in the Future, BYM Trustees – and Management Meeting, itself - are clear that the organisation needs to work more as a single, joined-up body, with effective strategic management overseeing all of the operational work.

Having interdepartmental responsibilities will allow Management Meeting to better prioritise concerns that sit across the organisation – church, charity and company. We expect this approach will improve the support offered to Quaker meetings; co-ordinate outreach work in our buildings and nationally; and strengthen our witness in the world.

This is not a cost-cutting exercise. However, having a smaller Management Meeting will also be a better use of funds, freeing up resources for other work.

A single Head of Worship & Witness will help committees work in a more joined-up way. Quaker Life and Quaker Peace and Social Witness Central Committees have both responded positively to this.

#### How and when are we going to do this?

The new structure will take shape over the next six months, with a view to the new roles being in place by January 2017. Some things have happened already – for example, Helen Drewery is working with both Central Committees.

#### How will this affect Quakers and Meetings?

Most Quakers will not notice any change in the short term. But Meetings should benefit from more effective work, in the medium to long term.

The current structure of Central and Standing Committees will remain the same, as will their responsibilities.

The existing departments will remain, as will current staff roles.

We hope the better structure will help staff respond more quickly and flexibly to enquiries from Quakers and others. Staff will work directly with colleagues across the organisation, rather than in departmental silos. Making BYM's strategic direction clearer will help staff to see how they contribute to the overall work of Quakers in Britain.

We see these changes as exciting and innovative. We know change can also be challenging: we are encouraging all staff to keep talking with members of Management Meeting and Trustees as we all move forward together.
