# MfS/16/10/07 Yearly Meeting Clerk and Recording Clerk's recent visit to the USA

Further to minute **MfS 16/07/19**, we have received back the travelling minute we agreed at our last meeting, and heard the endorsements from the two Yearly Meetings visited.

The Yearly Meeting Clerk, Deborah Rowlands, and the Recording Clerk, Paul Parker, have shared their reflections on their visit to Philadelphia Yearly Meeting, Baltimore Yearly Meeting, and other Quaker groups based in the East of the USA.

We have heard a little of their experiences and about the two Yearly Meetings. This included details on how they are organised and on concerns that are held with their Yearly Meeting. In particular, on racism, both within the wider society but also looking at inclusiveness and diversity within the Yearly Meetings; and the involvement of young adult Friends at all levels of the Yearly Meetings.

It has been good to get a flavour of the visit.

It is clear that there are many areas of commonality where we can learn from each other and share experiences, and we are glad to hear that Paul and Deborah are making links between Friends and groups on both sides of the Atlantic.

MfS/16/10/08 Quaker Peace and Social Witness Central Committee We have received a report from Quaker Peace and Social Witness Central Committee (QPSWCC) and Charlotte Seymour Smith, the clerk, has spoken about its work.

The Committee see their work as carried out very much in partnership with local Friends, supporting Quaker witness in local communities alongside the central work that is carried out on their behalf. Friends can see QPSW as a hub for local and national action for peace, justice and nonviolent change.

QPSWCC are working within the context of 'Our faith in the future' approved by Sufferings last year and are currently finalising the overall strategy for QPSW's work. They are not anticipating any dramatic shifts in the work or its areas of focus, but do want greater clarity in objective setting, and to further develop the links between QPSW work and that of Quaker Life.

The committee was clear that very small programmes of work use resources less effectively so a policy of grouping programmes together has been developed and found to lead to more creative connections.

Today we have appreciated more news about some of the rich tapestry of work that QPSW oversees in many different areas and feel that this is work that Quakers can be proud of and with which Friends can engage in ways that support and enrich their own faith.

We thank QPSWCC and all those who work on our behalf, and hold them in the Light.

## MfS/16/10/10 Living out our faith: prioritising and balancing

At our April meeting we considered issues forwarded to us by Yearly Meeting 2015, minute 36 (minute MfS/16/04/08 refers). Then, we considered Meeting for Sufferings' role, concluding that we can encourage and provide networking among Friends rather than seek to 'co-ordinate'. We also spent time considering how concerns are tested. Then, we did not have time to consider a third set of questions posed in our papers, encouraging us to explore how Meeting for Sufferings prioritises and balances different parts of the work we are called to do.

We have spent time this afternoon considering how we fulfil our responsibilities for setting priorities for centrally managed work (*Qf&p* 7.02.a). We recognise that we cannot know everything, and that we need to entrust the detail to our trustees, committees and staff.

Our Faith in the Future, as agreed by Sufferings last year, articulated our vision.

All of us on Meeting for Sufferings have a responsibility to prepare for meetings in reading and in prayer. Meeting for Sufferings has the breadth of experience among Friends to provide testing and discernment. We need to discern what is a Spirit-led Quaker concern, that no other body is doing, and what is work we should be doing with others.

# MfS/16/10/11 Peacebuilding: the Ammerdown Invitation

We receive **minute 16/07/50 of Brighouse West Yorkshire AM** held on 9 July 2016, regarding the Ammerdown Invitation.

The Ammerdown Group is made up of people involved in peace-building work who are increasingly concerned about the future of peace and security the UK and worldwide. Its members believe that our government is not responding effectively to the challenges of the new century, but with a marked change of course, it could be. The Group is keen to begin a public conversation about this in the UK, and has set out its vision for a more peaceful, less insecure world in the Ammerdown Invitation and a recent publication, 'Rethinking Security'.

In an accompanying note, Marigold Bentley, Assistant General Secretary of QPSW, has explained how QPSW is supporting and contributing to the work. She is a member of the Group, which is deliberately made up of a mix of professionals, academics, consultants, campaigners and thinkers, some of whom are Quakers. The Ammerdown Group's work complements and supports a wide range of Quaker peace work.

We encourage Friends to learn more about this work, and to support it where possible. This may be through hosting local community discussions.

We forward this minute to QPSWCC for information, and encourage Brighouse West Yorkshire AM to stay in touch with Marigold Bentley.

## MfS/16/10/12 Refugees

We receive minute **3a of East Kent AM** held on 14 May 2016, informing us that it has adopted a concern to support refugees, locally and also in Calais and Dunkirk. We forward this minute to QPSWCC for information.

## MfS/16/10/13 Yearly Meeting Accounts

We receive minute **8 of Central Yorkshire Area Meeting** held on 13 July 2016, which raises questions about the presentation of the Yearly Meeting accounts, and in particular the difficulty of identifying which expenditure is attributed to Friends House Hospitality Company.

It has been helpful to learn that the Yearly Meeting Treasurer is working with the Head of Finance and Resources, to improve the way the accounts are presented in future.

We forward this minute to BYM Trustees, asking them to respond to the Area Meeting.

### MfS/16/10/14 Cadet Forces in Scottish State Schools

We receive minute **10 of General Meeting for Scotland** held on 11 June 2016, regarding the proposed introduction of cadet forces to Scottish state schools to be financed from fines levied on banks. General Meeting for Scotland's Parliamentary Liaison Function Group is working on this, supported by the Parliamentary Engagement Officer. However, as the funding is allocated by the UK Government via the Ministry of Defence, the Scottish Government has no influence over how the funding is used

We forward this minute to QPSWCC, asking it to consider what work might be done alongside General Meeting for Scotland, and to report back in due course.

# MfS/16/10/15 Sustainability

Further to minute MfS/16/04/11, we receive minutes 16/06/04 and 16/06/14 of BYM Sustainability Group held 7-9 June 2016.

The Friends World Committee for Consultation (FWCC) World Plenary Meeting held in Pisac, Peru, this year, asked all Yearly Meetings to take actions. BYM Sustainability Group has sent us some suggestions.

We are glad to hear that the October 2016 Quaker Life Representative Council, titled 'Becoming the Change We Want to See' will bring together over 90 Friends to explore the spiritual underpinning of our Canterbury Commitment.

We also note that sixteen Friends met at Woodbrooke in June, exploring how our faith relates to ecology and sustainability.

Other work is being developed. BYM Sustainability Group encourages us all to consider new actions, finding ways to involve young Friends, and perhaps initiating exchange of resources and experience with other Yearly Meetings.

We forward this minute to Quaker World Relations Committee.
