Dear Friends,

Here are the minutes of our meeting last Saturday and I hope you are able to share some of our business with your area meeting in whatever ways you think work best. It might be good to talk this over with your area meeting clerk.

The key items are:

- 1) A consideration of the documents received from QLCC and YFGM and for us to try to understand the issues involved in the current debate around gender diversity. We heard that working in small groups to consider this may be a good way forward and that QLCC would like to receive further comments please send your comments to gender@quaker.org.uk We hope that when we return to this we may be able to articulate more clearly what specific Quaker contribution there may be to this issue, remembering that the basis of our response is love and the recognition that each person is a child of God.
- 2) The appeal for funds for the Sanctuary Everywhere has been sent to meetings but a link to the appeal leaflet may be found here Remember that donated monies should be extra for this programme and not a diversion from normal donations to BYM! Please click here if you would like to make a donation.
- 3) Do report to local Friends about the recent work of BYM trustees and their initial decision to develop work beyond the Vibrancy project to enable more local support for meetings. This was considered by both BYM and Woodbrooke trustees, working together. We heard that there are many more plans and decisions to be made and our minute recording this information concluded that we 'hold our trustees and our staff in the light as they continue to grapple with difficult decisions.
- 4) We also spent time considering the involvement of young people and others unable to attend a regular weekly local meeting for worship but who worship with us at other regular events and how we might best provide pastoral care in these situations.

MfS Arrangements Group meets in the third week of August to plan for our next meeting at the beginning of October and will be grateful for your upholding and any further input you may like to make. Please do email sufferings@quaker.org.uk

George Fox exhorts us to be patterns and examples so that our 'carriage and life may preach among all sorts of people... then you will come to walk cheerfully over the world, answering that of God in every one'. I hope we can heed this in today's world of political and social upheaval and I look forward to our meeting together again at Woodbrooke on October 4th-6th.

Further to minute MfS/19/02/05, concerning the action taken by Ian Bray (Brighouse West Yorkshire AM) in November 2018 as part of the Extinction Rebellion movement that led to his arrest, we note that he went to trial in Hendon Magistrates' Court on 10 May 2019. The proceedings were adjourned until 5 August for a case management hearing at Westminster Magistrates' Court.

We agree to include the above information in the court and prison register. We hold the Friends concerned in the Light. We are aware that other Friends have been involved in similar actions. If details are forwarded to BYM staff, they can also be included in the court and prison register.

MfS/19/07/05 Yearly Meeting 2019

We have received minutes from Yearly Meeting held on 24-27 May 2019.

We note that minute 6 asks Meeting for Sufferings to carry out a review of Yearly Meeting and Gatherings. We ask the Recording Clerk to bring a paper for discussion, about how this might be taken forward.

We note that minute 21 delegates responsibility to Meeting for Sufferings to revise Church Government text in *Quaker faith & practice* to keep it up to date while the new Book of Discipline is being prepared. Meeting for Sufferings is asked to continue to forward to Yearly Meeting any substantive matters of Quaker discipline which requires its attention, and to report any updates to Quaker faith and practice to Yearly Meeting, annually.

We have had an opportunity to reflect on our experience of Yearly Meeting this year.

The minutes of Yearly Meeting do not tell the whole story. There were many experiences, and much learning in many ways.

It is important to encourage those who feel moved but are diffident about speaking in a large group. We also value unspoken ministry and the experience of the "scale of stillness" that Yearly Meeting offers.

Minute 33 says: "We call on Friends throughout our Yearly Meeting to continue this work in our meeting communities, to deepen and extend the work we have done, so that we can be the community we need to be to face the future. We encourage local and area meetings to share their insights."

MfS/19/07/06 Gender Diversity

We receive and note minute 2019.2.3 of Young Friends General Meeting and the initial statement regarding Trans and non-binary inclusion; and Quaker Life Central Committee's initial statement 'Quakers and Gender Diversity'.

Friends are encouraged to reflect on the Quaker Life Central Committee (QLCC) initial statement and the Young Friends General Meeting (YFGM) minute, and to work together to explore the issues.

We are aware that we need to listen to those people affected by discrimination of any sort (to listen deeply, with open hearts); and we want Quakers in Britain to be welcoming and affirming of all people. Each individual is a child of God and we all seek to know that Love which is eternal.

We uphold all Friends in this exploration. Working in small groups may make it easier for Friends to share more deeply. We encourage everyone to listen carefully to the Spirit through each other. We hope to return to this later in the year.

MfS/19/07/07 Sustainability

We receive minutes 19.40 of Bristol AM held on 21 April, 19/28 of West Weald AM held on 12 May 2019, both concerning Extinction Rebellion, and minute 19/54 of Southern Marches AM held on 11 May.

West Weald AM has forwarded a statement issued on 21 April from a Meeting for Worship held at the Extinction Rebellion camp at Marble Arch in London.

Southern Marches AM's minute asks Britain Yearly Meeting to give more attention to climate breakdown. The AM would like to see more of the resources and organisational capabilities available within centrally managed work to be directed towards leading and coordinating the Quaker response across all AMs, and better enabling Quakers to participate in the activities of other organisations.

Our shared concern for the Earth and the well-being of all who live in it is not new. Through corporate discernment in local and area meetings, Meeting for Sufferings, Yearly Meeting and elsewhere, Friends in Britain have repeatedly re-affirmed our commitment to action. We recognise the urgent need to address climate breakdown.

We are reminded that Meeting for Sufferings holds responsibility for overseeing our corporate action (minute 18/07/20 refers). Last year we agreed that central and standing committees should continue to take increasing responsibility for their role in facilitating the progress of BYM to becoming a low carbon, sustainable community. With the help of our newly-formed Sustainability Monitoring Group, we will continue to ask committees to report on how their work is taking forward our commitment in five agreed areas:

- 1. Eldership: rooting the commitment in our Quaker faith
- 2. Oversight: Strengthening our community
- 3. Living faithfully: Changing our lifestyles
- 4. Right Ordering: Quaker core activities and property
- 5. Witness: Taking political action and promoting systemic change

We encourage all Friends to consider how they are called to respond to the crisis. Each person has a different contribution to make, and we can be stronger and make more difference if we work together and support each other. We will share this minute with our area meetings as appropriate.

The next meeting of representatives of central and standing committees will be held on 24 July. We forward this minute to that meeting and will hear more when we return to this matter in October.

MfS/19/07/08 Sanctuary Everywhere programme

We receive minute 3 of Staffordshire AM held on 19 May, regarding the future of Quaker Peace & Social Witness Central Committee's (QPSWCC) 'Sanctuary Everywhere' project. This work, which was intended to be time-limited, has been very successful. QPSWCC hopes to keep the programme running for a little longer in order to continue providing support, resources and advice to Sanctuary Meetings but also to develop more infrastructure, tools and resources, to help the network be more sustainable.

Sanctuary and other meetings have been asked to consider making an additional financial gift for this purpose.

We acknowledge our resources are not infinite, and uphold our central committees when they are faced with difficult decisions.

We forward this minute to QPSWCC.

MfS/19/07/09 Britain's withdrawal from the EU

MfS/19/07/12 Britain Yearly Meeting Trustees Report

We receive and note the minutes of Britain Yearly Meeting (BYM) Trustees meeting held on 5 April and on 7-9 June 2019.

Further to minute MfS/19/04/13, we also receive a paper regarding the Vibrancy in Meetings pilot (paper 2019/07/11b).

Caroline Nursey, clerk of BYM Trustees, has spoken to us about their recent meeting.

Trustees have spent time considering how best to support Quaker meetings and communities to thrive and grow, in the context of the review of the Vibrancy in Meetings project, which we heard about last time.

The joint statement issued by BYM trustees and Woodbrooke trustees includes the affirmation that: 'the Vibrancy in Meetings pilot project has shown that a meeting-centred approach to providing support can deepen our worship and transform our communities'.

Trustees agreed that the current model of locally-based development workers should be extended expanded so that there is a local development worker within reach of every meeting in Britain within 5 years, and that BYM will work rapidly towards more local support for Meetings and begin to experiment with new regional bases, hubs or clusters. This is about having support for local meetings, so we can take forward Friends' ministry.

Change will not happen overnight and have reminded us that some work that is dear to our hearts will have to be laid down to find the investment for meeting-centred support.

However, the time to invest in the future of Quakers in Britain is now, whilst we have reserves to enable the management of change - of infrastructure and of culture.

We have been able to ask questions today and we look forward to further updates.

We hold our trustees and our staff in the light as they continue to grapple with difficult decisions.

MfS 19/07/13 BYM annual report and financial statements

The annual report and financial statements for the year ended 31 December 2018 for BYM were agreed by trustees in their meeting on 5 April 2019 and presented to Yearly Meeting in May 2019. Linda Batten, BYM treasurer, has spoken about them with us today and we have been able to ask questions.

MfS/19/07/14 Young People's Involvement

We receive minute Minute 19.03.07 of Kendal and Sedbergh AM held on 16 March 2019, regarding the interpretation of advice for including young people in the annual tabular statement.

Paul Parker, Recording Clerk has spoken further about this matter. We acknowledge that people of all ages are not always connected to the Society primarily through regular attendance at a specific local meeting. We heard many practical ideas, including attention to "sensitive adult scaffolding" for youth events, and a plea to help our young people find their identity as Quakers.

We ask the Recording Clerk to review the advice sent to area meetings for completing the tabular statement, looking particularly at how to include Friends whose active participation in the Society is not based on a regular connection to a local meeting.

We send this minute to QLCC to encourage them to review their guidance about the pastoral care of such Friends, and to the Revision Committee to draw attention to this issue, which has a wider impact on membership.

MfS/19/07/15 Quaker Recognised Bodies
