Dear Friends,

As ever, there are a number of items we are asking you to take back to your meetings.

MfS/16/02/01 Opening worship

During our opening worship we have heard read parts of the epistle of the Friends World Committee for Consultation World Plenary meeting held in Pisac, Peru, 19-27 January 2016. We have also remembered former members of this meeting who have recently died.

MfS/16/02/02 Apologies

We receive apologies from Bournemouth Coastal AM, which has not been able to send a representative on this occasion.

MfS/16/02/03 Minutes

The minutes of our meeting held on 4-6 December 2015 have been signed.

MfS/16/02/05 Adoption of Agenda

The clerk has introduced the draft agenda, and we have agreed to this.

MfS/16/02/06 Court and prison register

Sam Sender, London West Area Meeting, was one of thirteen members of Plane Stupid arrested and charged in July 2015 at Heathrow Airport, as part of a campaign against a third runway. On 25 January at Willesden Magistrates Court all the defendants were found guilty of aggravated trespass and being airside without lawful authority. Sentencing is expected on 24 February. We hold Sam Sender in the light.

MfS/16/02/07 Quaker faith & practice: BYM Budgeting process

Further to minute MfS 2014/12/05/a, we have received advice from Church Government Advisory Group (CGAG) in response to minute 11/09/14 of Northumbria AM (part of paper MfS/2016/02/03).

Northumbria AM had felt that the process of budget setting is not clearly documented in Quaker faith & practice, and that there is a lack of clarity about accountability.

CGAG has reviewed the broad information set out in Quaker faith & practice. The text states that Meeting for Sufferings can set priorities for the centrally managed work, which needs to take account of the advice of BYM Trustees and funds available (7.02a). It also states that BYM Trustees approve the budget each year (8.16), and that they are enabled to employ staff to carry out BYM's work effectively (8.19): this could include preparing budgets.

We have been reminded that the purpose of Quaker faith and practice is to express the general principles underlying how the Yearly Meeting is organised, rather than to set out details which may not stand the test of time.

For these reasons, CGAG advises that it is neither desirable nor necessary to include additional detail at this time.

We accept this advice.

MfS/16/02/08 Refugees and asylum seekers

Quaker Peace and Social Witness has consulted Meeting for Sufferings in advance of testing options for possible further work to address the refugee crisis.

QPSWCC seeks advice on possible Quaker involvement in a scheme to support the private sponsorship of refugees (part of paper MfS/2016/02/03). The Government has stated, in general terms, that it is willing to run a Private Sponsorship scheme for refugees, in which community groups and individuals would agree to provide full support for a refugee, or a refugee family, for their first 12 months in Britain. Some national or regional bodies are registering their serious interest in becoming umbrella bodies who would encourage and support their members to participate in the scheme. QPSWCC is considering whether Quakers in Britain should take an initial step towards involvement. QPSW's helpful paper sets out the background, some practical information and possible implications, as well as arguments in favour and against.

We have heard mixed reactions to the proposal. There has been a 'guarded' yes from a number of Friends and Meetings, though with the understanding that a lot more work is needed on the scheme and in clarifying the impact of working with Citizens UK.

There have also been serious reservations expressed both about the scheme itself and the impact this could have on existing work with and services for refugees.

We have also heard about the importance of our work as Quakers addressing the underlying issues, including removing the causes of war.

We forward this minute to QPSWCC and hold them in the light in their consideration. We look forward to hearing from them of their progress.

MfS/16/02/09 Yearly Meeting 2016

Deborah Rowlands, clerk designate of Yearly Meeting, has told us about the proposed agenda for Yearly Meeting 2016. Copies of the spiritual preparation leaflet are being sent to Meetings; and we ask representatives to encourage Friends and Meetings to use this material.

We receive and note minute YMAC/2015/10/15 regarding numbers attending Yearly Meeting, and ask representatives to encourage Friends to register for Yearly Meeting in advance.

MfS/16/02/10 Yearly Meeting 2018 and 2019

Minute MfS/11/02/8 agreed a three-yearly pattern for the dates of Yearly Meeting.

We receive minute YMAC 2015/11/14 proposing that Yearly Meeting should be held 4-7 May 2018 and 24 – 27 May 2019, both at Friends House London. We agree to this.

MfS15/02/11 Our faith in the future: mind the gap

At our meetings in September and December 2015, Meeting for Sufferings has grappled with some important issues. In September, we looked forward at our vision and we accepted Our Faith in the Future as our new framework document, 'as a guide for our future discernment and decision- making.' In December we looked at where we are now, in particular the 'nature and state of our area meetings in Britain' – hearing of both hope and struggle and emphasising the importance of communication and education within and amongst Friends.

Today we have considered how to address the gap between where we are now, and where we want to be.

We recognise that Meeting for worship is the bedrock of living as a Quaker. In looking at what we do together discernment, 'listening to the will of God' and following our leadings, are all key phrases that we use. We recognise that Quakerism is not learnt by osmosis and that newer Friends and attenders do not always understand what these mean. We need to be willing to explain, explore, test and practice our ways.

We need to be willing to speak with a confident voice, both to the outside world and within our own Meetings.

MfS/16/02/12 BYM Sustainability Group

Frances Voelcker, a member of the BYM Sustainability Group, has spoken to the Group's written report (paper MfS/2016/02/07).

We are encouraged to hear of the work that is already happening across the Yearly Meeting. We are disappointed to learn that currently only about half of AMs have appointed representatives to attend the Sustainability Gathering in March. We encourage all AMs and other invited bodies to try to appoint a representative. The conference is a valuable opportunity for sharing ideas and re-energising Friends.

We are also pleased to support the BYM Sustainability Group in developing the 'Nurturing our Sustainability Ministry' project and look forward to hearing more about this in the future. We thank the Group for its ongoing work on our behalf.
