## QUAKER UNITED NATIONS SUMMER SCHOOL

**4<sup>th</sup> to 16<sup>th</sup> July 2010, Geneva**

The Summer School aims to provide an introduction for people to the work of the United Nations, as seen through the programmes of QUNO - the Quaker United Nations Office in Geneva. QUNO works on disarmament and peace, human rights and refugees, and global economic issues. During Summer School there will be talks by staff of the UN, non-governmental organisations and diplomatic missions, as well as informal discussion sessions and visits to the UN itself.

The work of some of the UN specialised agencies will also be examined and, where possible, visits will be arranged to, for example, the International Committee of the Red Cross and the Office of the UN High Commissioner for Refugees. The group will be introduced to the organisations by people working within them and will be encouraged to further their understanding by asking questions and contributing to discussion.

In the programme, emphasis will be given to formal and informal discussion sessions to provide opportunities for participants to gain a deeper understanding of the issues being studied. A variety of learning techniques will be employed, including lectures, small group discussions and workshops.

The twelve days in Geneva are not all work - Geneva is surrounded by magnificent walking country and has a lake to swim in. Geneva itself is a fascinating city with some particularly fine historic buildings and many cultural and recreational activities.

### Practical details

The 2010 Summer School will be held from Sunday 4<sup>th</sup> July to Friday 16<sup>th</sup> July. Participants will stay in single-sex dormitories at a hostel in Geneva. Breakfast, packed lunch and evening meal will be provided by the hostel. Participants will be expected to share in some domestic duties involved in meal preparation for meals we have at Quaker House.

The participation fee for the summer school is £490, which goes towards the costs of accommodation, programme and meals. Travel costs to Geneva and spending money are not included. Some suggestions on how to seek financial help will be provided if you are

accepted; however applicants will be encouraged to seek funds from their own Meetings, where appropriate, first.

## Who can apply?

The annual Quaker United Nations Summer School in Geneva provides an opportunity for 25 people to meet together to study the work of the United Nations at first hand.

Participation is not limited to Quakers, although they are usually in the majority. We welcome applications from anywhere in the world. Applicants from outside the EU/Switzerland will need a visa, which QUNO will assist in applying for.

No formal qualifications are necessary. However an active interest in international affairs is needed, as well as the desire to share understanding with others.

English is the working language used throughout the programme. Therefore fluent English is essential for those taking part.

### **CLOSING DATE FOR RECEIPT OF APPLICATIONS IS 15<sup>th</sup> MARCH 2010**

Usually we receive more applications than there are places available. Selection is made by a special group and letters informing applicants if they have been accepted will be despatched by the middle of April 2010.

Participants will be required to pay a deposit of £100 on acceptance of a place on the Summer School.
