



# Adult and Further Education Grants: Guidance

Please read these notes carefully before completing the application form.

## Introduction

Our grant making focusses on faith-led concerns that enable change. Britain Yearly Meeting has funds available to support the work of local and area meetings for furthering the aspirations of individual Friends.

## Adult and Further Education Grants

These grants are paid from part of the income from various endowments which make up the Friends Educational Foundation and Legacies, and are specifically for the support of Friends' post-compulsory education.

There is insufficient funding to support all applications and applicants will need to demonstrate clearly how they meet eligibility criteria, especially financial details of how shortfall in ability to pay occurs and level of self funding planned.

Occasionally an award may be granted to an applicant who presents an exceptional case which does not meet all of the criteria but applicants should address all criteria, including the ones that are not met

A single grant will be awarded to each successful applicant. This award may be distributed over a maximum of three years, depending on the nature of the course and whether study is full time or part time. Payments for the second and third years will be conditional upon the Grants Group receiving satisfactory annual progress reports from both applicant and tutor.

## Eligibility

### Individuals should meet all of the following requirements:

- Members of Britain Yearly Meeting, or attenders of at least five years (this may be waived for applicants showing evidence of strong support from the local meeting or another Quaker body). All applicants should be in good standing with a meeting
- Mature Students, i.e. not school/college leavers, but including graduates undertaking postgraduate studies
- In need of some financial support to undertake the course
- Be able to show how they will fund the costs of their course and demonstrate clearly that they have a realistic financial plan to do so
- Have at least a provisional place on their chosen course
- Explain how their new qualification will enable them to serve society and/or the Religious Society of Friends.
- Applicants should have assured themselves that the direction they have chosen to take is spirit-led, and should indicate who has helped with the discernment process – for example if they have held a meeting for clearness, had a discussion with an elder/elders, or a discussion with a group of Friends.



## **Courses should meet all of the following requirements:**

- Full- time or part-time lifelong learning courses within the post-compulsory education sector, including vocational, further or higher education or continuing professional development.
- Nationally validated courses that offer transferable qualifications, knowledge and/or skills
- Offered at a recognised, reputable institution or professional body within the UK

## **Please bear in mind:**

- Applicants studying for a first degree have access to student loans for tuition fees; these applications will be considered, but will be given a low priority
- Anyone under 60 may apply for a maintenance loan; these applications will be considered, but will be given a low priority
- The Equipping for Ministry Course offered by Woodbrooke is **excluded**, as the cost is normally expected to be borne by Meetings.
- Courses leading to doctorates are expensive and a grant is unlikely to make a significant contribution to total costs; these applications will be given a lower priority

## **Applying for Adult and Further Education Grants**

### **Forms**

Please fill in the form fully. If you have any difficulties with this, please contact the Grants Programme Officer.

### **Dates**

Grants Group will consider applications three times a year, at their June, September and November meetings. The closing date for applications will be 6-8 weeks before the meeting - please see the website for the next closing date for your application. Applicants will normally be advised of decisions in the month following Grants Group's meeting, with payments made within two months of the meeting. Grant recipients must inform the Grants Officer if they make any changes from the details in their applications regarding their course (e.g. level of degree, subject area, full time/part time etc.). Any substantial change might affect the grant awarded.

### **References**

At least two references are required. One of these will be from a Quaker (preferably a role-holder with pastoral care responsibilities) who knows the applicant's personal circumstances, and the other will be an academic reference from someone (probably a tutor or employer) who can comment on the suitability of the course and the likelihood of the applicant succeeding on it. It is the applicant's responsibility to get agreement from the referees to act in this role, to give them the reference forms and to ensure that references arrive before the closing date as applications will not be processed.

### **Sums available**

Each year the grants are based on the needs of the applicants but are governed by the level of demand from suitable applicants and the funds available. In 2025 the average size of grant awarded for the year was £2,654.
