### **Registering officers**

Registering officers have been sent a request for information about marriages that have taken place in 2023. All area meetings need to have a registering officer (Qf&p 4.04 & Qf&p 16.22). If an area meeting does not currently have a registering officer, then please let Michael Booth know by emailing wedding@ quaker.org.uk, he will be in touch and can explore possibilities for different ways of filling the role.

Changes of registering officers should be reported to BYM staff without delay, as we need to inform the civil authorities. When your area meeting appoints a new registering officer, please send the minute of appointment, together with the name, address and email of the Friend being appointed, to wedding@ quaker.org.uk (this email address is monitored by Graham Spackman and Michael Booth). We also need to know when a registering officer resigns or is released from service.

We will then do the necessary administration, which includes writing to the new registering officer welcoming them to their task.

#### **Quaker trustees handbook revision**

The Quaker trustees handbook revision is nearing completion. A draft has been prepared in collaboration with Woodbrooke and many Friends have commented on it and helped shape the text to make it as useful as it can be for Quaker needs. The new revision will have more of a focus on the Quaker aspects of trusteeship and point towards the places where secular aspects of charity trusteeship can be found from charity regulators.

The draft text is currently with BYM's lawyers to ensure that the document is fit for purpose legally. We expect the legal comments to be complete so that the design of the handbook can be worked on during December and January. The plan is that the final revision will be ready and with Friends in Spring 2024.

#### **Quaker charities memorandum of understanding**

The Quaker charities memorandum of understanding work is ongoing and reaching the point where a final document will be available, and meetings will be asked to sign.

To give a very brief update on where things are:

- On 6-8 October Meeting for Sufferings approved the draft document.
- It is currently with BYM's lawyers undergoing final scrutiny to ensure that it does not create additional commitments between the parties.
- In late 2023 to early 2024 the document will be formally finalised, and a published version will be available. Meetings will be notified through the usual channels.
- In Spring 2024 those Quaker bodies requested to join the MoU will be sent a copy with advice on how to sign.

#### **Reporting to BYM**

Now that the work on the BYM charities memorandum of understanding is almost complete thought has been given to how and what is reported to BYM by area meetings on compliance. In previous years

separate governance and safeguarding reports have been sent out for trustees to complete. We would like to bring all this reporting together so that it happens in one place annually, and can be passed to Quaker Life Central Committee, who report on this to Meeting for Sufferings.

A new online form has been developed which gives the opportunity to report everything in one place. It will cover all the following areas:

- Charity regulatory compliance
- Safeguarding
- Annual sustainability reporting
- Policies and risk management
- Record keeping
- Serious incidents or notifiable events

Many of these are areas that trustees are asked to report on so please let your AM clerks of trustees know to expect to receive the form. You can look at the form online here. Please only make one submission per area meeting.

#### **Pollard and Dickson Trust**

Pollard and Dickson Trust hardship grants are for members and attenders of Britain Yearly Meeting and those of other Yearly Meetings resident in Great Britain at time of application. Grants are for up to  $\pounds$ 1,000.

## **Hope Grants**

Hope Grants are small grants to improve the quality of life of Quaker members and attenders who are unemployed or unable to make a living wage. Friends in financial need can apply for a grant of up to £750 towards items or activities that will improve their quality of life.
