# MfS/19/04/04 Agenda

The Clerk has introduced the draft agenda, and we have agreed to this.

# MfS/19/04/05 Court and Prison Register

### a) Record of recent witness

Further to our minute MfS 2019/02/05, we are reminded that last December Lyndsay Burtonshaw, an attender at Brighton Meeting, was found guilty along with 14 others

known together as the Stansted 15, of intentional disruption of services and endangerment at an aerodrome under the 1990 Aviation and Maritime Security Act.

We note that Lyndsay received a 12-month community order with 100 hours of unpaid work.

We have heard that Marita Over, an attender at Llanidloes Meeting, was arrested in Cardiff as part of an Extinction Rebellion protest. She has been charged with aggravated trespass and will appear in court on 9th April.

Brighouse West Yorkshire AM has also informed us that Jilly Chadwick was arrested during an anti-fracking demonstration in late February. She was held for 5 hours in a police cell in Preston for obstructing the highway, but was later released without charge.

We agree to record this information in the Court and Prison Register. We hold Lyndsay Burtonshaw, Marita Over and Jilly Chadwick in the light.

## b) The parameters of the Court and Prison Register

We receive minute 4/2019 of York Area Meeting informing us that Christine Abbot, an attender at Friargate Meeting, lost a contract with the Church Commissioners in 2017, following a year's successful work, without right of appeal, on the grounds that she was attending Quaker worship and refused to give any assurance that she would cease to do so.

We agree to minute this information about Christine Abbott.

York Area Meeting has asked us to re-examine the parameters of the Court and Prison Register. We feel this needs further consideration before making a decision and will return to the matter at a future meeting.

We forward this minute to QCCIR.

#### MfS/19/04/06 BYM Trustees

Caroline Nursey, clerk of BYM Trustees, has reported on the Trustees meeting held on 15-16 February 2019. Further to our minute MfS 2018/11/13 we receive and note minute BYMT 2019/02/15 regarding the adoption of strategic priorities for centrally-managed work. Caroline has told us more about Trustees' consideration of the relationship between BYM and area meetings and how best to support area meetings in their compliance with statutory requirements. Meeting for Sufferings is involved in the life of area and local meetings and is aware of some of the issues at regional level. We may need to return to this.

We have also heard from Linda Batten, BYM treasurer. The annual report and accounts for the year ended 31 December 2018 were agreed by Trustees yesterday and headline figures are that both income and expenditure are down on the previous year. The loss of £3million for the year includes a stock value loss of £2.3million and the reserves, of which two thirds are held in property, stand at £77 million. Although about £5million was gifted by Friends in 2018, Quaker support was actually down by £0.75million. We continue to be supported more by deceased Friends than by those alive today! The Hospitality Company provided a record-breaking £1.3million of income.

The accounts will be available in full for Yearly Meeting in May and we are encouraged to read them.

We thank all Trustees for their work.

## MfS/19/04/07 Diversity and Inclusion

"As Friends we commit ourselves to a way of worship which allows God to teach and transform us. We have found corporately that the Spirit, if rightly followed, will lead us into truth, unity and love: all our testimonies grow from this leading." QF&P 1.01

We have been reminded that Yearly Meeting has asked us to consider diversity in our committee and organisational structures and to think of ways in which Quakers can remove barriers and seek wider participation in the full life of our meetings.

Edwina Peart, Inclusion and Diversity Co-ordinator, has presented a second report to MfS, describing information gathered from the diversity and inclusion survey and from the national gathering on diversity and inclusion held at Woodbrooke. Around 1600 people have responded to the survey and were a self-selecting sample. Edwina has more work to do on analysing the results, but today she has shared with us some further reflections about ethnicity, gender and class in particular. She has found Quakers are, at their core, a community of people committed to a loving, simple and rich-in-the-spirit way of life.

We have spent time in seven separate groups considering the following questions:

- 1. Does anyone have a claim on the universal?
- 2. Do Quakers think that everyone should aspire to become middle class by middle age?
- 3. What makes for a welcoming welcome?

A report will be compiled from feedback received from the groups.

In the concluding plenary session we reflected that some things are visible and others invisible – those in a dominant group are not always aware of their dominance. We need to know ourselves and the 'baggage' we hold to enable us to be truly welcoming of others. 'Jesus asks us to love each person, whoever they are; not necessarily to agree or approve, but to love at a deep level. There should be no 'other' – we are all family.'

We are reminded of the importance of listening to each other at a deep level. We heard that diversity, inclusion and privilege will be considered at Yearly Meeting in May and we will return to the matter again.

#### MfS/19/04/08 National Health Service

We receive minute 19.02 of Bournemouth Coastal Area Meeting, which has adopted a concern to uphold a universal, publicly provided Health Service. This has grown from and builds on local circumstances, including proposed changes to health services in Dorset.

We forward Bournemouth Coastal AM's minute to Area Meetings, encouraging them if appropriate to learn more about the concern and to consider taking action. AM clerks are welcome to read documents available on the Bournemouth and Coastal AM website, and to contact the AM's clerk for further information.

## MfS/19/04/09 Britain's withdrawal from the European Union

We receive part of minute 2019.08 of Meeting of Friends in Wales held at Aberystwyth on Saturday 23 February 2019 which contains a statement that Meeting of Friends in Wales have agreed. It draws attention to the importance of peace within Europe and in the UK and shares distress about the degree of inequality that is evident in our society today. We unite with this statement.

We are aware of the great turmoil that currently exists in the political spectrum and are reminded that whatever the political outcome, we will continue to live lives that focus on love, both of our fellow beings and of the planet, and to seek to follow the leadings of the Holy Spirit that may be found within each of us.

# MfS/19/04/13 Vibrancy in Meetings

Our minute 2018/10/09 refers.

We have received a copy of the executive summary of the Vibrancy in Meetings programme evaluation by the NCVO charities evaluation service together with a report on options being considered by Woodbrooke and BYM trustees (paper MfS 2019/04/13). Caroline Nursey (BYM trustees) and Michael Hutchinson (Woodbrooke trustees), Martin Ford (Vibrancy steering group) and Suzanne Ismail (Head of

Networking and Engagement) have been with us today and we have heard that trustees will be considering this matter again at their meeting in June.

Caroline began by explaining that the median number of members in local meetings has fallen from 24 to 18 in the last ten years, but there are now more children's meetings than ten years ago and 16 'Young Adult Friends' groups around the country.

Michael explained Woodbrooke's desire to work more with Friends on the ground to build Friends' confidence and foster their ministry.

We are united in our desire to make Quakerism more accessible to others and to build our local meetings in to more vital and resonant communities.

Martin has told us about the work of the steering group and explained this is the third evaluation report that they have received. The outcomes for Friends involved in the project are that they have felt much better supported, and feel happier, more confident role holders.

Meetings have felt transformed particularly in the areas of community, Quaker discipline and collaboration. (Half of the meetings currently served reported deeper quality of ministry at their meetings).

We have read that simply replicating the pilot on a larger scale may not be the best way forward. Suzanne explained that it could be adapted, either by a phased roll-out which would take a transition period of about five years, or by pursuing further decentralisation opportunities so that some functions/ services are delivered from locations other than London and Birmingham: although these models may overlap more than we think.

Meeting for Sufferings has been asked how either of these options might support Quakerism to thrive in your area.

There is considerable enthusiasm today for the Vibrancy programme and a wish that it should continue. Friends have spoken of their experience in being supported by local development workers, enabling them to feel engaged with Quakers in Britain.

Both the parliamentary work in Scotland and the youth work in Yorkshire have shown how a more decentralised approach can work well.

We have also heard that some changes will be needed. We hope that our consideration today has been useful.

We send this minute to BYM Trustees, to Woodbrooke Trustees and to Quaker Life Central Committee.
