## MfS/20/02/04 Prison and Court register

Heather Rostron, an attender at Sheffield Central local meeting, was arrested during Extinction Rebellion actions on 22 April 2019, 8 October 2019 and 10 October 2019 and for each arrest has been charged and appeared in court. On 1 November 2019, in the City of London Magistrates' Court, she was found guilty of wilful obstruction of the highway and failing to comply with a condition imposed by a senior police officer under section 14 of the Public Order Act 1986. She was given 6 months' conditional discharge, and court costs and victim surcharge amounting to £105. On 22 October 2019, in Westminster Magistrates' Court, she was found guilty of failing to comply with a condition imposed by a senior police officer under section 14 of the Public Order Act 1986. On this occasion, the Crown Prosecution Service has subsequently said the proceedings may be reopened, following a judgement in the High Court on 9 November 2019 that the police condition was imposed unlawfully. On 7 November 2019, at Westminster Magistrates' Court, she was found guilty of aggravated trespass and given 12 months' conditional discharge, and court costs and victim surcharge of £106.

John Lynes, a member of Sussex East Area Meeting, was found guilty at Folkestone Magistrates' Court on 5 December 2019 of breaching Section 14 of the Public Order Act on 21 September, in the course of an Extinction Rebellion event. He was given a conditional discharge for 18 months and ordered to pay court costs.

We agree to include this information in the Prison and Court Register. We hold Heather Rostron and John Lynes in the Light.

### MfS/20/02/05 Quaker Council for European Affairs

Josh Habgood-Coote, BYM representative to Quaker Council for European Affairs (QCEA), has spoken to his written report (paper MfS 2020 02 06).

QCEA is based in Brussels, in a building owned by BYM. It is supported financially by the yearly meetings of both EU members and non-member states, and works with the Council of Europe, NATO and the Organisation for Security and Co-operation in Europe, as well as the EU. There are two key areas of work: The peace programme of QCEA aims to promote a process of 'rethinking security' and sets out to challenge the dominant narrative that conflict is best resolved by military means. The publication 'Building Peace Together' (2018) has reached a wide range of stakeholders and been translated into seven languages. It has been followed by a Peace Education report in January 2019. Peacebuilding is everyone's business.

Highlights of the human rights programme include work on child immigration detention and raising awareness of online hate speech, through a pilot project called #ChooseRespect.

Alongside high quality policy research and advocacy, QCEA engages in 'quiet diplomacy' – bringing together people in an informal, off-the-record setting to build common ground. The Quaker reputation for trustworthiness and integrity is vital in facilitating discussions that lead to real change.

Friends were impressed by the report and interested to hear about QCEA's financial situation. We affirmed the need for Friends in Britain to continue (and ideally to increase) support for the work of QCEA, both materially and spiritually.

The need for peace, and work towards it, has not lessened overnight, as we have left the EU.

#### MfS/20/02/07 BYM Trustees

Trustees have not met since our December meeting, so this was an opportunity for Caroline Nursey, clerk of BYM Trustees, to talk about the broader agenda of trustees work over the coming months and to seek the discernment of Friends.

Some trustee decisions need to be made quickly, for a variety of operational reasons. Other decisions can be explored at greater length, and trustees are keen to engage in more of a conversation with Meeting for Sufferings to test such matters.

One of the most important matters considered in 2019 was the setting of strategic priorities for the work of BYM the charity. In doing this trustees were guided by the vision expressed by MfS in Our Faith in the Future. The work aims to:

- Encourage thriving Quaker communities, reversing the risk of an ageing and declining membership
- Work for a sustainable and peaceful world, responding to the twin emergencies of climate change and violent conflict
- Simplify structures and practices, including the revision of Quaker faith & practice.
- And to do all of this in ways which are distinctively Quaker, integrated across our Yearly Meeting, and well-governed.

Meeting-centred support, regional hubs and local development workers are all part of the first strand of encouraging thriving Quaker communities.

A number of questions were posed about plans for regionalisation and local development workers:

- What will be the impact at Friends House?
- What will be the balance between national specialist and other generalist support?
- Also, how long can we sustain deficit budget?

We were assured that the process of change will be gradual and the wealth of expertise within BYM staff will not be lost. Regionalisation is welcomed by many.

We are thankful to have had this opportunity to engage with trustees and we hold them in the Light.
