It was interesting to reflect on the work on emerging patterns for area meetings in London and Wales & the Marches which we had considered in some detail at the preparatory session on 28 June. I'm sure many of us know the problems area meetings are facing, and want to address them, but don't know where to start. Being able to hear from two different areas about the experiments they are making as they look for solutions may offer encouragement.

After the routine business of nominations we reflected on Yearly Meeting and the implications of its minutes for Sufferings. Arrangements Group will be looking at ways to foster our learning about the important issues raised.

The report from BYM Trustees showed us quite how much work they do – described by their clerk as 'nuts and bolts' – on our behalf. Of particular interest to Friends at

The Clerk has introduced the agenda and we have agreed to it.

#### MfS/22/07/04 Truth, integrity and democracy

We have received paper MfS 2022 07 05, which outlines the slow erosion of democratic rights and norms that we have witnessed in the UK in recent years.

Following the introduction of the Lobbying Act in 2014 which restricted campaigning ahead of general elections, Quakers in Britain convened the Civil Society Voice network. It has developed into a vital space for organisations to discuss and take joint action on a range of threats to civic space, for example the Police, Crime, Sentencing and Courts Act and criticism of charities who are exploring racism, colonialism and white privilege.

Democracy matters, and when it is weakened equality, peace and truth all suffer; signs of the divine order to which Quakers testify on the basis of our perception of the Light available to all to which we are called to attend. While individual restrictions upon participation in the democratic process may seem insignificant, the cumulative effect may be catastrophic and have disproportionate impact on those who are already marginalised. Quakers reject the idea that only powerful voices should be heard. Where we disagree, can we keep the argument going, listening to one another, and with mutual respect and love for as long as it takes to discern a way forward?

We have a tradition of speaking truth to power and exercising quiet diplomacy. Sometimes our role may be to minister in compassion to the oppressor as well as to the oppressed. This may be a moment when we can make significant contributions to the public realm in collaboration with other faith groups and secular organisations.

We have heard expressions of frustration and helplessness, along with anger and fear, and also of hope from Friends. We have also heard a call for assistance for local Friends to articulate and campaign on their concerns around this issue. We have heard appreciation of the Quaker Truth and Integrity Group as well as the involvement of local Friends in public affairs and hope that our central structures can work to support and enhance these initiatives.

We also receive minute 22/30 (paper MfS 22 07 05a) from Quaker Peace and Social Witness Central Committee's (QPSWCC) meeting last weekend. We ask QPSWCC to consider how to accommodate this concern in their ongoing strategy, working in partnership with other interested parties.

#### MfS/22/07/05 Speaking Out – our policy in action

BYM adopted its Speaking Out Policy in 2012, and it is set out in *Quaker faith & practice* 3.27 and 3.28.

We have received a presentation from David Loxton, Head of Communications & Fundraising, together with Elizabeth Payne, Communications Officer, and Cato Pedder, Media Officer. We have been reminded of the provisions of the policy and have heard case studies of recent examples of speaking out on behalf of Quakers in Britain on current issues.

We thank our Friends warmly for their presentation and commend the efforts of our communications staff in representing us to the world.

#### MfS/22/07/06 Emerging alternative forms for area meetings

We receive paper MfS 2022 07 07, which is a report of work being undertaken to consider new ways for area meetings to come together.

The paper, supplemented by a preparation session about developments in London and in Wales & the Marches attended by around 60 Friends, gave insight into possible pathways to change. There is a clear understanding and appreciation of the difficulties faced by area meetings, with a dwindling number of members, in fulfilling the responsibilities laid upon them as charities.

We were asked to answer the following questions:

- Is Meeting for Sufferings content to see significant amalgamations of area meetings (and other bodies) take place?
- Are there implications that may need the attention of other Yearly Meetinglevel bodies, such as the Book of Discipline Revision Committee, Church Government Advisory Group, Meeting for Sufferings Review Group (regarding how larger bodies should be represented on Sufferings), or Quaker Life Central Committee (regarding the provision of appropriate support)?

Friends recognise the importance of releasing energy for worship and witness, thus allowing their Quaker community to flourish and thrive. We are content in principle to see significant amalgamations of area meetings and other bodies. We noted however that there are implications that may need attention from Meeting for Sufferings or other Yearly Meeting-level bodies, for example – how would local Friends be represented at national level?

There was also an appetite for further consideration of the emotional aspects of the hard work of change, and a plea for finding a way to consider the issues facing local meetings as well as their engagement with area meetings.

#### MfS/22/07/09 Reflections on Yearly Meeting 2022

We received Yearly Meeting minutes 25, 27, 31 and 33 which are of direct relevance to Meeting for Sufferings.

The theme of Yearly Meeting, held in blended form at Friends House in May, was 'Faith, community and action'.

- Faith: How do we experience worship, community and witness?
- Community: How can we build Quaker communities that respond to challenges and put faith into action?
- Action: How can we transform thinking and action in Quaker communities and wider society?

In taking time to reflect on Yearly Meeting 2022 we heard tremendous enthusiasm for the experience of the blended meeting, recognising the excellent technical support that enabled it. Those present in person were also enthusiastic about the spaciousness afforded by moving the preparatory sessions online in the preceding week.

With regard to the themes in the minutes we received, we heard that our discernment on reparations is still at an early stage. We still may not fully understand the implications of our decision, which must involve work within our own worshipping groups as well as more widely. We are not alone among faith groups in looking at this issue. The Yearly Meeting minutes empower and require us to act on anti-racist and anti-oppressive work, uncomfortable though this is bound to be for many.

We ask our Arrangements Group to consider how we might take this matter forward in future meetings.

#### MfS/22/07/10 BYM Trustees

We receive MfS 2022 07 10 introduced to us by Caroline Nursey, Linda Batten and Danielle Walker Palmour, and also the annual report and accounts for 2021.

Trustees have met twice since our last Meeting for Sufferings, including in Leeds at the Quakers in Britain Yorkshire Centre. Friends heard about the range of business Trustees have covered, and were able to ask questions. We are glad to know of their engagement with Woodbrooke Trustees about how the two organisations can best work together to complement each other.

We have reviewed the registration of each of the following organisations:

#### MfS/22/07/12 War in Ukraine

In March, Meeting for Sufferings received prepared ministry on war in Ukraine and following discernment agreed a minute (minute MfS/22/03/23) which it sent to Quaker Peace & Social Witness Central Committee (QPSWCC). We receive QPSWCC separated minute 22/15 in response. We have also received a spoken update on the developing situation and work that Friends have undertaken in response.

Friends are deeply grateful that BYM staff and QPSWCC have been able to act so quickly and offer all involved our prayerful support.
