


Descriptions

Diversity and inclusion I

In 2017 Yearly Meeting heard the call to examine our own diversity, particularly in our committee and organisational structures, locally and nationally. Britain Yearly Meeting employed an Inclusion and Diversity Coordinator to help Quakers in Britain consider our own diversity, to look at how to be fully inclusive, and to decide what needs to be done next.

In this session we will hear an overview of this work. Edwina Peart, Inclusion and Diversity Coordinator, will reflect on her experience of raising these issues within the Quaker community. The enthusiasm of Friends, and the obstacles encountered, will be discussed under the spotlight of privilege and power.

In addition, Edwina will facilitate a panel presentation addressing several aspects of diversity and inclusion. Invited panellists will speak to the themes of class, transgender and disability, sharing how these interests can be incorporated onto our welcome of newcomers as well as impacting on already-established Friends.

Diversity and inclusion 2

Vanessa Julye, who works with Friends General Conference and American Friends Service Committee, will talk about her experience in the US on empowerment work with Youth Ministries and Young

Adult Friends; the White Privilege Conference; and her book Fit for Freedom, not for Friendship: Quakers, African Americans, and the myth of racial justice. Vanessa has visited BYM in previous years, speaking at Special Interest Groups. The session will be facilitated by Tim Gee.

Exceptionalism

'Exceptionalism' is a perception of being somehow special, superior, or different from the norm. For instance, people may feel that human survival and flourishing is more important than that of other species. People in Britain may feel entitled to ways of life and forms of privilege - including flying, driving, high levels of meat and dairy consumption, and centrally heated homes – that contribute to the climate crisis and are not available to most of the world's population.

Do we find excuses or justify our 'normal' actions and choices, knowing that they harm people, communities, ecosystems and the future of life on earth?

Are some harms truly justified as healthy self-care, or necessities in our work for much-needed social change?

What is our experience of applying individual and corporate spiritual discernment to such questions? And have we found ways forward that feel rightly led?

Facilitated by Laurie Michaelis of Living Witness, we will receive reflections on our theme from Lindsey Cook, QUNO Climate Representative; Fletcher Harper, Director of GreenFaith, which is coordinating a global interfaith collaboration on sustainable living (by video), and Anthea Lawson, anti-corruption campaigner and activist (by video).

Exploring privilege through dance

Saturday:

Sunday:

Dancing for the planet

We will experiment on the themes of diversity & inclusion and climate justice & sustainability. These sessions will be facilitated by Ann Bettys and Robin Bowles. Ann sets up the dance and Robin accompanies with improvised music on a variety of instruments. Sometimes the dance leads, sometimes the music leads. Ann characterises the session as "meeting for worship through dance".

Imagine life in 2030

In this workshop-style session, we will use ideas from Zero carbon Britain: rethinking the future (www.quaker.org.uk/ym/documents) to help guide our thoughts about the future. By inviting our imaginations to carry us beyond 2030 we glimpse new possibilities and unexpected joys, along with loss, sadness, challenges and all kinds of new norms. What might these visions of our future reveal? What might they call forth from each of us and from our Quaker community?

On Saturday this session will be facilitated by Ro Randall, member of the Climate Psychology Alliance and co-founder of Carbon Conversations, and Tanya Hawkes, who works on sustainability and adaptation to climate change at the Centre for Alternative Technology (CAT), which has produced Zero carbon Britain: rethinking the future.

On Sunday the session will be facilitated by Clíodhna Mulhern who has been leading workshops and retreats on sustainable living and spiritual ecology for the last decade.

Philosophy for communities

Philosophy for communities (P4C) is a method which provides a structure for a group to participate in rigorous exchange about questions that matter. In this 'community of enquiry' we will use the morning's Yearly Meeting session as the stimulus for our thinking, and the group will choose and develop a question to focus the discussion. Expect to be encouraged and challenged to progress your thinking, drawing on your lived experience and working collaboratively with others.

Facilitated by 2018 Eva Koch scholar at Woodbrooke Rosie Carnall, who developed a resource pack to encourage use of P4C by Quakers. She will be accompanied by Helen Griffin, a senior P4C trainer with SAPERE, the umbrella organisation for P4C.

There will be opportunities to practise this method on either Saturday or Sunday in a group limited to 30 participants.

Singing in the Spirit

Singing to save the planet, global warming and sustainability facilitated by Alison Breadon and Patrick lones.



Sharing stories of climate breakdown

Sharing stories of climate breakdown from our own world, family of Friends brings the reality of chaos closer to home. Understanding our geographical privilege as British Friends – because the wealthy world has been so far relatively safe from the immediate impact of climate chaos – helps us see our shared responsibility more clearly. In this session we will step into the shoes of Friends who do not share this privilege, notice any feelings that arise for us, and see what insights this process brings. Facilitated by Alex Wildwood and introduced by Susanna Mattingly from Friends World Committee for Consultation, we will share the video Quakers and climate change stories from around the world.



Quakers share a way of life, not a set of beliefs. Their unity is based on shared understanding and a shared practice of silent worship, where they seek a communal stillness.

Quakers seek to experience God directly, within themselves and in their relationships with others and the world around them. They meet together for worship in local meetings, which are open to all who wish to attend.

Quakers try to live with honesty and integrity. This means speaking truth to all, including people in positions of power. The Quaker commitment to peace arises from the conviction that love is at the heart of existence and that all human beings are unique and equal.

This leads Quakers to put their faith into action by working locally and globally to change the systems that cause injustice and violent conflict.
