## 1. Welcome to the Spring issue!


## 2. Praise for Quake! Good job, BYM

## 3. Charity Commission, HMRC & related news

#### 3.1 Handy guidance from the Charity Commission

Guidance for trustees can be quite lengthy. The Charity Commission has recently introduced its 5-minute Guides for Charity Trustees. They can be found at <a href="http://bit.ly/5-minGuides">http://bit.ly/5-minGuides</a> and cover financial oversight; achieving a charity's purposes; good decision making; addressing conflicts of interest; what to file with the Commission and what support is available.

#### 3.2 Virtual meetings of trustees

We wonder if trustees should consider having their charity's Governing Document modified, if necessary, to allow virtual meetings to be held once the exceptional permission for such meetings ends as we approach the end of lockdown measures. It could be prudent future-proofing. The Trustee gathering on Blended Meetings organised by QSC seemed fairly certain that blended meetings will be part of the Quaker future.

#### 3.3 Caretakers/wardens and tax

Something that is set to expire at the end of March 2021 is the extra statutory concession (relating to posts that existed before 6 April 1977) by which the accommodation provided for caretakers is exempt from tax. From April 2021, it seems that the exemption will cover only those employed in full-time caretaking jobs who are on-call outside normal working hours. #### 3.4 National Living Wage – new rates from April.

Twenty-three and twenty-four year olds are now included.

#### 3.5 Implications for the end of lockdown

The lockdown escape plan contains some information relevant to places of worship: From 8 March, six people are able to attend a wedding, and from 29 March it will no longer need to be in exceptional circumstances. There is currently no change in the requirement for those attending a wedding to wear face coverings and maintain social distancing. Attendance at funerals continues to be limited to thirty. It is hoped that from 12 April fifteen people will be able to attend a wedding and a reception afterwards; from 17 May that figure will be thirty and, from 21 June all attendance restrictions will be lifted.

Most BYM staff are back from furlough, working from home. Staffing continues to be affected by the impacts of the pandemic, such as childcare and some sickness, and there have been staff departures, and changes of responsibility; but as far as possible support for AM trustees and treasurers is continuing as before. #### 5. News on registration

The registration of previously excepted charities (which includes 20 AMs) was meant to be completed by the end of March 2021. This has now been extended by 10 years to March 2031. It is expected that the Charity Commission will introduce phased registration of excepted charities based on income. See Mary Aiston's article in *The Friend* (12 March 2021). We can expect further details later this year.

#### 7. Do we need to revisit GDPR?

It is now some time since we were hit by GDPR. We may have dealt with it and effectively put it to one side. But has anything changed? Did we really complete it in every respect? Can we put our hands on the written policy we should have about what to do if we have a data breach? Do we recall that such a breach has to be reported to the Information Commissioner's Office within 72 hrs? The ACAT website (to which all AMs and LMs have access) has two 50 minute videos, covering the legal points and the practical implementation, which are well worth a revisit or even a first-time visit.

## 8. Gleanings from the Treasurers' Cluster

The long running discussion about accounting software and Area Meetings continues. QSC are no more willing now than they were before to offer a firm recommendation. Nor is ACAT. Very sorry.

### 9. Future online and blended meetings

On 11 February, QSC arranged a meeting for AM Trustees to talk together about Blended Meetings, which was reported in *The Friend* of 26 February. There was a strong sense that Blended Meetings are a way forward for Friends. Trustees will already be thinking about their responsibilities for inclusion and diversity of those who might become subject to a 'digital divide' in which some Friends might feel excluded by new technology. The pandemic has presented very significant questions to all Quakers, including treasurers and trustees, and has shown us new opportunities and ways of working which may become embedded in our practices. We hope that the emergence from the pandemic will be seen as an opportunity to tackle the future shape of our meetings, our ways of worship and of doing business and how our distinctive and valuable witness can continue through the decades to come.

#### 10. Trustees conversations – Burial grounds

A recent online meeting of AM Trustees organised by QSC discussed the serious subject of burial grounds. Beyond the advice in *Quaker faith & practice* (14.31, 14.32 and 14.34) there are some duties which trustees should note which apply even for out of use burial grounds. In addition to the obvious responsibilities of inspecting for decrepit walls, tumbling grave markers and unstable trees, there is a legal requirement to keep a register of burials, their locations and the names of those buried at each location. Details of the duties are available, set out in guidance from the Department of Constitutional Affairs in their 'Guide for Burial Ground Managers (November 2005): <a href="http://bit.ly/BurialGrounds">http://bit.ly/BurialGrounds</a>. We heard of some cases of disputed leases and rights. Trustees would do well to review the documentation of ownership and control. If these are unclear or disputed, competent legal advice becomes highly advisable (and it's a trustee duty to take appropriate advice). Friends Trusts Limited may be able to suggest firms that have been found adequate. Some of the interesting points for discussion included charging for plots and whether plots can be reused after a time.
